**PacificSource ID Card Distribution:**

Student ID cards **only** available online via Intouch.

**Enrollment/Eligibility:**

PacificSource to handle enrollment/eligibility/waivers for FALL and SPRING Undergraduate students.

Graduate students will use the PacificSource online enrollment system to enroll in coverage.

**Roster Notes:**

Students are terminated by omission on the initial roster and final roster only. Any student that is left off a weekly roster that is submitted in the period between the initial and final roster will not be terminated from the plan **unless** specifically requested (via email or termination file).

**Termination Letters:**

Loss of creditable coverage letters are supplied to students on request.

**Joyages:**

Joyages is a preventative care program for brain health. Addresses loneliness, stress, depression, anxiety, and suicide through a confidential, on-demand app that delivers self-directed guidance through a robust offering of videos, training, and habit tracking.

**Welcome Emails:**

PacificSource will send a "Welcome email" to all students that are enrolled for each coverage period. Fall email distribution: The week following the date the final roster is processed.

Spring email distribution: The week following the date the final roster is processed.

**Voluntary Student Re-enrollment Emails:**

PacificSource to send reminder emails to students to re-enroll/pay for upcoming coverage. These are programmed to send 2 business days before the portal opens and then a reminder 2 business days before the portal closes, to those who have not acted.
