

## **SUMMARY ANNUAL REPORT**

### **For REED COLLEGE WELFARE BENEFIT PLAN**

This is a summary of the annual report of the REED COLLEGE WELFARE BENEFIT PLAN, EIN 93-0386908, Plan No. 515, for period 01/01/2022 through 12/31/2022. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Insurance Information**

The plan has contracts with CANOPY, INC., KAISER FOUNDATION HEALTH PLAN OF THE NORTHWEST, WILLAMETTE DENTAL INSURANCE, INC., METROPOLITAN LIFE INSURANCE COMPANY and STANDARD INSURANCE COMPANY to pay Medical, Dental, Vision, Life Insurance, Long-term Disability, Accidental Death and Dismemberment, and Employee Assistance Program claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2022 were \$8,633,928.

Because WILLAMETTE DENTAL INSURANCE, INC. and STANDARD INSURANCE COMPANY are so called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending 12/31/2022, the premiums paid under such "experience-rated" contracts were \$556,190 and the total of all benefit claims paid under these contracts during the plan year was \$615,033.
